

Terms and Conditions of “FC Barcelona Goal Campaign”

FC Barcelona Goal Campaign

1. The following Terms & Conditions shall apply to Rakuten Trade Sdn. Bhd. (“Rakuten Trade”) “**FC Barcelona Goal Campaign**” (hereinafter referred to as “the Campaign”) which shall be held from 21st October 2018 up to the end of the 2018- 2019 UEFA Champions League and 2018 -2019 La Liga (hereinafter referred to as “the Campaign Period”).
2. Subject to these Terms & Conditions, the Eligible Participants will be rewarded with double Rakuten Trade Points (“**RT Points**”) upon FC Barcelona winning any match in the UEFA Champions League and La Liga. RT Points are points awarded to Eligible Participants through Rakuten Trade website.

Eligibility

3. By participating in this Campaign, you hereby agree to be bound by the following Terms and Conditions.
4. The Campaign terms and conditions (“Terms and Conditions”) shall apply to all existing and new customers of Rakuten Trade who have activated any Rakuten Trade account (“**Eligible Participants**”).
5. Rakuten Trade employees shall be eligible to participate in this Campaign.
6. Any individual who is below the age of eighteen (18) years as of the activation date with Rakuten Trade shall NOT be eligible to participate in this Campaign.

Campaign Mechanism

7. All Eligible Participants will be automatically enrolled in the Campaign.
8. Subject to these Terms and Conditions, upon FC Barcelona winning any match in the UEFA Champions League or La Liga during the Campaign Period, Eligible Participants will be rewarded with double(x2) RT Points for every RM2.00 of the brokerage trade through Rakuten Trade.
9. Where FC Barcelona wins a match on a day Bursa Malaysia Securities Berhad is open for trading, RT Points will be awarded on the same day. Where FC Barcelona wins a match on a day Bursa Malaysia Securities Berhad is not open for trading or has closed, the RT Points will be awarded on the next market day.

General

10. The Terms and Conditions of the Trade & Earn Points Campaign shall apply and be read together with these Terms and Conditions. In the event of any inconsistency, the terms and conditions of the Trade & Earn Points Campaign shall apply.
11. By participating in the Campaign, all Eligible Participants are deemed to have agreed to be bound by these Terms & Conditions. Rakuten Trade's decision on all matters relating to the Campaign is final, binding and conclusive. No correspondence, queries, appeals or protests will be entertained.
12. Rakuten Trade reserves the right to cancel, terminate, suspend the Campaign with or without any prior notice. For the avoidance of doubt, cancellation, termination or suspension by Rakuten Trade shall not entitle any of the Eligible Participants to any claim or compensation against Rakuten Trade for any losses or damages suffered or incurred by the Eligible Participants as a direct or indirect result of the act of cancellation, termination or suspension.
