

# Terms and Conditions of “#Raku10Mix & MoneyMatch”

## #Raku10Mix & MoneyMatch

1. The following Terms & Conditions shall apply to Rakuten Trade Sdn. Bhd. (“Rakuten Trade”) “#Raku10Mix & MoneyMatch” (hereinafter referred to as “the Campaign”) which shall be held from 1<sup>st</sup> to 30<sup>th</sup> April 2019 has been extended to 31<sup>st</sup> May 2019 (hereinafter referred to as “Campaign Period”).

## Eligibility

2. By participating in this Campaign, you hereby agree to be bound by the following Terms and Conditions.
3. The Campaign terms and conditions (“Terms and Conditions”) shall apply to all new and existing Rakuten Trade customers who have activated a Rakuten Trade account (Cash Upfront or Contra) (“**Eligible Participants**”) during the Campaign Period. A Rakuten Trade account is activated upon the issuance of a Central Depository System (CDS) number.
4. Rakuten Trade clients who terminate an existing Rakuten Trade account and thereafter activate a new Rakuten Trade account (Cash Upfront or Contra) during the Campaign Period shall not be allowed to participate in this Campaign.

9. Provided that the Eligible Participant concurrently opens and activates both a Rakuten Trade Cash Upfront and Contra account, the Eligible Participant shall receive Money Match promo code(s) worth RM80.00 that can be used to pay MoneyMatch transaction fees.
10. The MoneyMatch promo code(s) shall be emailed to the Eligible Participants within forty eight (48) business hours upon activation of the Rakuten Trade account.
11. The MoneyMatch promo code should be validated within five (5) months from the Campaign Period failing which the MoneyMatch promo code shall be invalid.

Eligible Participants and Existing Holders who open and activate a 2<sup>nd</sup> Rakuten Trade account by 31 May 2019 shall email Rakuten Trade's customer service by 31 May 2019, 6:00pm at [customerservice@rakutentrade.my](mailto:customerservice@rakutentrade.my) to be eligible to earn their MoneyMatch promo code(s). The respective Eligible Participant and/or Existing Holder shall provide the relevant information as requested by Rakuten Trade.
13. Eligible Participants, Rakuten Trade Employees and Existing Holders must activate their Rakuten Trade account latest by 31 May 2019 at 4:30 p.m. to qualify for the MoneyMatch promo code(s).

## **General**

14. Save for the "Two is Better Than One Campaign", no other Rakuten Trade account opening related campaign shall be applicable during the Campaign Period.
15. By participating in the Campaign, all Eligible Participants and Rakuten Trade Employees are deemed to have agreed to be bound by these Terms & Conditions. Rakuten Trade's decision on all matters relating to the Campaign is final, binding and conclusive including but not limited to disqualifying any Eligible Participant, and Rakuten Trade Employees from participating in the Campaign without providing any reasons.
