

## **Terms and Conditions “RakuTrade & Go Campaign”**

1. The following Terms & Conditions shall apply to Rakuten Trade Sdn. Bhd. (“Rakuten Trade”) **“RakuTrade & Go Campaign”** (hereinafter referred to as “the Campaign”) which shall be held from **3 May 2021 – 30 June 2021**. (hereinafter referred to as “Campaign Period”).

### **Eligibility**

2. By participating in this Campaign, you hereby agree to be bound by the following Terms and Conditions.
3. The Campaign terms and conditions (“Terms and Conditions”) shall apply to all new customers of Rakuten Trade who have activated a Rakuten Trade account (“Eligible Participants”). A Rakuten Trade account is activated upon the issuance of a Central Depository System (“CDS”) number.
4. Existing Rakuten Trade customers with single or double account(s) who activate a second or third Rakuten Trade account during the Campaign Period (“Existing Holders”) are eligible to participate in this Campaign.
5. Rakuten Trade customers who terminate an existing Rakuten Trade account and thereafter activate a new Rakuten Trade account during the Campaign Period shall not be allowed to participate in this Campaign.
6. Rakuten Trade employees are eligible to participate in this Campaign but shall be limited to Cash Upfront account opening only (“Rakuten Trade employees”).

#### **A. New Customer Account Opening**

8. All Eligible Participants shall be automatically enrolled in the Campaign.
9. Subject to these Terms and Conditions, Eligible Participants who open and activate a Rakuten Trade account during the Campaign Period and enter the promo code tab with **“RAKUGO”** on page 1 of the application form shall be rewarded with a **Touch ‘n Go eWallet Credit** worth **RM18.00** per account activated.
10. Touch ‘n Go eWallet Credit shall **not** be awarded if Eligible Participants fail to include the word **“RAKUGO”** in the application form.
11. Eligible Participants must activate their Rakuten Trade account by 30 June 2021, 4.30 pm to qualify for the Touch ‘n Go eWallet Credit.

## **B. Existing Client Account Opening**

12. Existing Holders who open and activate a second or third Rakuten Trade account pursuant to this Campaign through the login dashboard shall choose the answer “**Promotion**”; “**TnG eWallet**” for the question “What inspired you to open another account with us?”
13. Touch ‘n Go eWallet Credit shall **not** be awarded if Existing Holders fail to answer the question “What inspired you to open another account with us?” with the answer “**Promotion**” and “**TnG eWallet**”.
14. Existing Holders must activate their Rakuten Trade account by 30 June 2021, 4.30 pm to qualify for the RM18 Touch ‘n Go eWallet Credit per account.

## **General**

15. No other Rakuten Trade account opening related campaign shall be applicable during the Campaign Period.
16. The “**RAKUGO**” promo code will supersede all other Rakuten Trade account opening related campaigns.
17. Should a Referral Code (under the Raku Friends Campaign) be used together with the “**RAKUGO**” promotion code in the Referred Participant’s account activation process, the Referred Participant shall only receive rewards from the RakuTrade & Go campaign.
18. Touch ‘n Go eWallet Credit shall be credited by Touch ‘n Go eWallet to Eligible Participants and Existing Holders’s Touch ‘n Go eWallet app within **thirty (30) calendar days** after account/s activated.
19. The Touch ‘n Go eWallet Credit will be credited to Touch ‘n Go eWallet app based on the mobile number registered in Rakuten Trade’s page 1 of the application form.
20. The terms and conditions of the Touch ‘n Go eWallet Credit (Touch ‘n Go eWallet Terms) shall apply in addition to these Terms and Conditions. In the event of any inconsistency between these Terms and Conditions and the Touch ‘n Go eWallet Terms only to the extent of the Touch ‘n Go eWallet Credit, the Touch ‘n Go eWallet Terms shall prevail.
21. The Touch ‘n Go eWallet Credit is non-transferable to any third party, non-negotiable and nonexchangeable for cash or other items. Rakuten Trade and/or Touch ‘n Go eWallet shall have the right and discretion to remove or substitute the voucher code with any other item of similar value without prior notice.
22. The Touch ‘n Go eWallet Credit can only be used in the Touch ‘n Go eWallet app.
23. By participating in the Campaign, Eligible Participants are deemed to have agreed to be bound by these Terms & Conditions. Rakuten Trade’s decision on all matters relating to the Campaign is final, binding and conclusive. No correspondence, queries, appeals or protests will be entertained.

24. Rakuten Trade reserves the right to cancel, terminate, suspend the Campaign with or without any prior notice. For the avoidance of doubt, cancellation, termination or suspension by Rakuten Trade shall not entitle any of the participants to any claim or compensation against Rakuten Trade for any losses or damages suffered or incurred by the participants as a direct or indirect result of the act of cancellation, termination or suspension.

Any variation, additions, deletions or amendments to the Terms and Conditions herein shall be binding on the Participants and be deemed to be brought to the attention of the participants through any notice displayed at Rakuten Trade's website.

Rakuten Trade shall not be held liable and/or responsible for any loss, damage or any other form of liability (including indirect, consequential or economic losses, loss of profits, and loss of opportunity) in whatsoever nature and howsoever arising or suffered by any participants directly or indirectly from the Campaign.

Rakuten Trade shall not be held liable for any default of its obligation under the Campaign due to any force majeure event which include but is not limited to an act of God, war, riot, lockout, industrial action, fire, flood, drought, store or any event beyond the reasonable control of Rakuten Trade.

29. This Campaign shall be governed by and construed in accordance with the laws of Malaysia and subject to the exclusive jurisdiction of the Courts of Malaysia.
