

Terms and Conditions of “Share Transfer-In Program”

Share Transfer-In Program

1. The following Terms & Conditions shall apply to Rakuten Trade Sdn. Bhd. (“Rakuten Trade”) **Share Transfer-In Program**” (hereinafter referred to as “the Program”) held from 6 August 2018 to 31 May 2019 has been extended to 31 December 2019 (hereinafter referred to as “the Program Period”).

Eligibility

2. By participating in this Program, you hereby agree to be bound by the following Terms and Conditions.
3. The Program terms and conditions (“Terms and Conditions”) shall apply to all existing and new customers of Rakuten Trade who have activated a Rakuten Trade account (“**Eligible Participants**”). A Rakuten Trade account is activated upon the issuance of a Central Depository System (CDS) number.
4. Employees of Rakuten Trade shall be eligible to participate in this Program.
5. Any individual who is below the age of eighteen (18) years as of the activation date with Rakuten Trade shall NOT be eligible to participate in this Program.

Program Mechanism

6. All Eligible Participants will be automatically enrolled in the Program.
7. Subject to these Terms and Conditions, effective 6 August 2018 the Eligible Participants will be rewarded with 500 Rakuten Trade Points (RT Points) for every successful share transfer to Rakuten Trade during the Program Period.
8. For the purpose of this Program, shares transferred between Rakuten Trade’s Cash Upfront account and Contra Account shall not be recognised.

General

9. The Terms and Conditions of the Trade & Earn Points Program shall apply and be read together with these Terms and Conditions. In the event of any inconsistency, the Terms and Conditions of the Trade & Earn Points Program shall apply.
10. By participating in the Program all Eligible Participants are deemed to have agreed to be bound by these Terms & Conditions. Rakuten Trade’s decision on all matters relating to the Program is final, binding and conclusive. No correspondence, queries, appeals or protests will be entertained.
11. Rakuten Trade reserves the right to cancel, terminate, suspend the Program with or without any prior notice. For the avoidance of doubt, cancellation, termination or

suspension by Rakuten Trade shall not entitle any of the Eligible Participants to any claim or compensation against Rakuten Trade for any losses or damages suffered or incurred by the Eligible Participants as a direct or indirect result of the act of cancellation, termination or suspension.

12. Rakuten Trade reserves the right at its absolute discretion to amend, delete or add to any of these Terms and Conditions at any time with or without prior notice. Any variation, additions, deletions or amendments to the Terms and Conditions herein shall be binding on the Eligible Participants and be deemed to be brought to the attention of the Eligible Participants through any notice displayed at Rakuten Trade's website.

Rakuten Trade shall not be held liable and/or responsible for any loss, damage or any other form of liability (including indirect, consequential or economic losses, loss of profits, and loss of opportunity) in whatsoever nature and howsoever arising or suffered by any Eligible Participants directly or indirectly from the Program.
14. Rakuten Trade shall not be held liable for any default of its obligation under the Program due to any force majeure event which include but is not limited to an act of God, war, riot, lockout, industrial action, fire, flood, drought, store or any event beyond the reasonable control of Rakuten Trade.
15. This Program shall be governed by and construed in accordance with the laws of Malaysia and subject to the exclusive jurisdiction of the Courts of Malaysia.
